RESOLUTION NO. 73-2-11

- WHEREAS, THE Oneida Indians of Wisconsin have a share in the Immigrant New York Indians Claim Award as provided for in Indian Claims Commission Docket No. 75, and
- WHEREAS, these funds were approved and appropriated by the Act of May 29, 1967 (81 Stat. 50) to pay the judgement by the Indian Claims Commission, and
- WHEREAS, as provided in Congressional Act, Public Law 90-93, 90th Congress, S. 1972, September 27, 1967, Section 5, funds so appropriated for the Immigrant New York Indians, of which the Oneida Tribe of Indians of Wisconsin is a member, placed for their credit, may be used, advanced, expended, deposited, invested, or re-invested for any purpose that is authorized by the Tribal governing bodies thereof and approved by the Secretary of the Interior, and
- WHEREAS, in compliance with Section 5 of this Act, the Oneida Indians of Wisconsin, through its General Tribal Council, enacted and adopted Resolution No. 7-67A, dated July 3, 1967, which provided that the Oneida Tribe approves the reservation of fifteen percent (15%) of their share of the net claims judgement awarded in Docket No. 75 for reservation programs, and
- WHEREAS, this resolution was approved by the Secretary of the Interior, through the Commissioner of Indian Affairs, as delegated by Secretarial Order 2508, on July 2, 1968, and
- WHEREAS, by resolution dated July 3, 1967 numbered 7-67 B and resolution dated October 1, 1968, were also enacted and adopted by the General Tribal Council which provided for repayment of \$60,000 Revolving Credit Fund Loan and pledging \$48,000 for an E.D.A. application for the Oneida Industrial Park, and
- WHEREAS, the Oneida Indians of Wisconsin are interested in and concerned about reservation improvement for all its members,
- THEREFORE BE IT RESOLVED, that \$75,000 be advanced to the Oneida Indians of Wisconsin, for reservation improvement, as part of the fifteen percent (15%) reserved for programming, from the invested funds that will first mature and be available for advancement to the Tribe as provided for in Section 5 of the previously mentioned Act.
