Resolution 06-09-99F Unemployment Compensation Coverage for the OBC


- WHEREAS, the Oneida Tribe of Indians of Wisconsin is a federally recognized Indian government and a treaty tribe recognized by the laws of the United States, and
- WHEREAS, the General Tribal Council is the governing body of the Oneida Tribe of Indians of Wisconsin, and
- WHEREAS, the Oneida Business Committee has been delegated the authority of Article IV, Section I, of the Oneida Tribal Constitution by the Oneida General Tribal Council, and
- WHEREAS, the Oneida Nation of Wisconsin voluntarily participates in the State of Wisconsin, Chapter 108, Unemployment Reserves and Compensation, and
- WHEREAS, Under the State of Wisconsin, Unemployment Reserves and Compensation, Chapter 108.02, (15)(f), employment as applied to work for a government unit does not include service as an official elected by vote of the public, and
- WHEREAS, the Oneida Business Committee members are officials elected by vote of the Oneida Nation General Tribal Council membership, and
- WHEREAS, employment as applied to work for a government unit, can include Oneida Business Committee members with the department's approval, and
- WHEREAS, the Oneida Nation recognizes unemployment as an urgent public problem, gravely affecting the health, morals and welfare of the Oneida Nation, and
- WHEREAS, the Oneida Nation recognizes the economic burden resulting from unemployment, and

WHEREAS the Oneida Nation desires that Oneida Business Committee members be eligible to receive unemployment compensation pursuant to Wisconsin Chapter 108, Unemployment Reserves and Compensation.

NOW THEREFORE BE IT RESOLVED, that the Oneida Nation of Wisconsin hereby request that the Wisconsin Department of Unemployment Reserves and Compensation approve the Oneida Business Committee members for unemployment compensation under Wisconsin Chapter 108.

CERTIFICATION
