## RESOLUTION # 6-12-96-G

- WHEREAS,** The Oneida Tribe of Indians of Wisconsin is a federally recognized Indian Government and Treaty Tribe recognized by the laws of the United States, and
- WHEREAS,** The Oneida General Tribal Council is the governing body of the Oneida Tribe of Indians of Wisconsin, and
- WHEREAS,** The Oneida Business Committee has been delegated the authority of Article IV, Section of the Oneida Tribal Constitution by the Oneida General Tribal Council, and
- WHEREAS,** The State of Wisconsin, Department of Transportation, has made application for a Permanent Limited Easement over Oneida tribal property in order to make road improvements on Highway 54, and
- WHEREAS,** The request for Permanent Limited Easement involves the following parcel of Oneida Tribal Trust Land:

ALL THAT LAND OF GRANTOR IN LOT 18 OF SECTION 25, T24N, R19E, CITY OF GREEN BAY, BROWN COUNTY, WISCONSIN, LYING WITHIN THE FOLLOWING DESCRIBED TRAVERSE:

COMMENCING AT THE SOUTH ONE-QUARTER CORNER OF SAID SECTION 25; THENCE N 2904'04"W ALONG A RANDOM LINE FOR 250.13 FEET TO THE STH 54 REFERENCE LINE; THENCE N 5117'48"E ALONG SAID REFERENCE LINE FOR 1578.45 FEET TO THE POINT OF BEGINNING; THENCE N 80°59'21"E FOR 100.94 FEET TO THE PROPOSED SOUTHERLY RIGHT-OF-WAY LINE OF STH 54; THENCE N 80°59'21"E ALONG SAID LINE FOR 59.09 FEET TO A POINT "A"; THENCE CONTINUING N 80°59'21"E FOR 33.30 FEET TO THE PLEASANT LANE REFERENCE LINE; THENCE N 01°15'47"W ALONG SAID REFERENCE LINE FOR 35.61 FEET TO A CURVE WITH A RADIUS OF 100.00 FEET AND A CHORD BEARING N 09°58'59"W, 30.32 FEET; THENCE NORTHWESTERLY ALONG SAID REFERENCE LINE AND CURVE TO THE LEFT 30.44 FEET; THENCE CONTINUING ALONG SAID REFERENCE LINE N 18°42'11"W FOR 43.53 FEET TO THE STH 54 REFERENCE LINE; THENCE ALONG SAID REFERENCE LINE S 51°17'48"W FOR 219.06 FEET TO THE POINT OF BEGINNING. SAID PARCEL CONTAINS 0.03 ACRE, MORE OR LESS. ALSO INCLUDED HEREIN IN 0.03 ACRE, MORE OR LESS, LYING WITHIN THE EXISTING RIGHT-OF-WAY.

and

**WHEREAS** The length of term for the Permanent Limited Easement shall be permanent from the date of approval and

**WHEREAS,** The State of Wisconsin, Department of Transportation, has also made application for a Temporary Limited Easement for ditching on that land of the Tribe in Lot 18 of Section 25, T24N, R19E, from said point "A" south for 45 feet, including for such purposes the right to operate necessary equipment thereon, the right of ingress and egress, and the right to preserve protect, remove or plant any vegetation thereon until completion of the Highway 54 construction project, and

**WHEREAS.** The State of Wisconsin and the Oneida Tribe have negotiated the amount of compensation and damages for the above-mentioned easements and have agreed it shall be Two Thousand Three Hundred Dollars and No Cents (\$2,300.00).


**NOW THEREFORE BE IT RESOLVED** that the Oneida Tribe of Indians of Wisconsin hereby grants to the State of Wisconsin, Department of Transportation, a Permanent Limited Easement over the above-described property for the purpose of making road improvements to Highway 54, and

**BE IT FURTHER RESOLVED** that the Oneida Tribe of Indians of Wisconsin hereby grants to the State of Wisconsin, Department of Transportation, the requested Temporary Limited Easement for the purposes enumerated above, and

**BE IT FINALLY RESOLVED** that the Chairperson of the Oneida Business Committee is hereby authorized to execute the attached Permanent Limited Easement, for and on the behalf of the Oneida Tribe of Indians of Wisconsin, said document containing both of the above-described grants of easements.

#### CERTIFICATION
