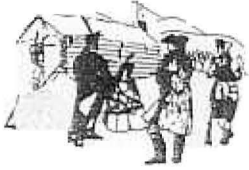

Oneidas bringing several hundred bags of corn to Washington's starving army at Valley Forge, after the colonists had consistently refused to aid them.


## RESOLUTION 6-19-96-L

- WHEREAS the Oneida Tribe of Indians of Wisconsin is a federally recognized Indian Government and a Treaty Tribe recognized by the laws of the United States, and
- WHEREAS the Oneida General Tribal Council is the governing body of the Oneida Tribe of Indians of Wisconsin, and
- WHEREAS, the Oneida Business Committee has been delegated the authority of Article IV, Section 1 of the Oneida Tribal Constitution by the Oneida General Tribal Council, and
- WHEREAS, the Oneida Tribe has acquired in fee status the following parcel described as: LARRY J. & MICHELE J. LESAGE, 3144 DAYS END LANE, GREEN BAY, WI., TAX PARCEL NO. #6H-2668
- WHEREAS the parcel is described as follows:  
Lot Eighty-nine (89), according to the recorded Plat of Green Ridge Estates, said plat being part of Lot One (1) and part of Lots Three (3), Four (4), Five (5) and Six (6) of the Northwest Quarter (NW¼), Section Thirty (30), Township Twenty-Four (24) North, Range Twenty (20) East, in the Fourth Principle Meridian, in the City of Green Bay, West side of Fox River, Brown County,
- WHEREAS the above described parcel is requested in trust status to expand Oneida Tribal land base and provide a future site for economic development, housing, recreation, conservancy, and agriculture, and
- WHEREAS, the Oneida Business Committee certifies that the local property taxes will be paid up to trust placement, and

NOW, THEREFORE BE IT RESOLVED, that the Oneida Business Committee hereby requests that the United States Bureau of Indian Affairs to initiate and carry out the process required to place the above parcels in trust for the Oneida Tribe of Indians of Wisconsin.
