BC Resolution # 07-22-98-A

Resolution Adopting the Hunting Fishing and Trapping Law

WHEREAS, the Oneida General Tribal Council is the duly recognized governing body of the Oneida Tribe of Indians of the Wisconsin, and

WHEREAS, the General Tribal Council has been delegated the authority of the Constitution of the Oneida Tribe of Indians of Wisconsin, and

WHEREAS, the Oneida Business Committee may be delegated duties and responsibilities by the Oneida General Tribal Council and is at all times subject to the review powers of the Oneida General Tribal Council, and

WHEREAS, the Oneida Tribe wishes to uniformly regulate hunting and fishing within the reservation boundaries and under Tribal jurisdiction for the health, safety, and welfare of those wishing to hunt and fish, and

WHEREAS, uniform regulation helps to monitor and maintain fish and game within the reservation and under Tribal jurisdiction,

WHEREAS, the Hunting, Fishing and Trapping Law adopted in 1994 required amendments to maintain the protections in this law, and

WHEREAS, the Hunting, Fishing and Trapping Law has been presented at Public Hearing and the comments and testimony reviewed and integrated as appropriate,

NOW THEREFORE BE IT RESOLVED: that the Oneida Business Committee adopts the Hunting and Fishing Law for implementation 30 days after the date of adoption, and

NOW THEREFORE BE IT FURTHER RESOLVED: that all other resolutions, motions, laws, policies, regulations and parts thereof, involving hunting and fishing regulation are hereby repealed unless specifically re-adopted after adoption of this law, and

NOW THEREFORE BE IT FURTHER RESOLVED, that the Environmental Resources Board is directed to develop and present any necessary public meeting to disseminate the changes in this law to the public, and

NOW THEREFORE BE IT FINALLY RESOLVED, that the Conservation Department is directed to identify individuals holding licenses and mail a postcard indicating that changes to the Hunting, Fishing and Trapping Law have been adopted and when copies of the current law will be available.
