## Resolution # BC- 8-16-95-A

WHEREAS, the Oneida Tribe of Indians of Wisconsin is a federally recognized Indian government and a treaty Tribe recognized by the laws of the United States of America; and

WHEREAS, the Oneida General Tribal Council is the governing body of the Oneida Tribe of Indians of Wisconsin; and

WHEREAS, the Oneida Business Committee has been delegated the authority of Article IV, Section 1 of the Oneida Tribal Constitution by the Oneida General Tribal Council; and

WHEREAS, there is a need for a more organized process of creating, reviewing and implementing resolutions of the Oneida Tribe, and

WHEREAS, the Legislative Operating Committee has been delegated the responsibility to review and process all potential laws and policies of the Oneida Tribe,

NOW THEREFORE BE IT RESOLVED, that all resolutions proposed for adoption by the Oneida Business Committee or the Oneida General Tribal Council shall be processed through the Legislative Operating Committee for legislative and legal analysis which shall be presented through an attached "Statement of Effect."

NOW THEREFORE BE IT FURTHER RESOLVED, that all resolutions must complete this process to be considered for final approval by the Oneida Business Committee.

NOW THEREFORE BE IT FURTHER RESOLVED, that the following types of resolutions shall be exempt from the requirement of a Statement of Effect:

Resolutions for grant applications

Indian Health Service Resolutions

Resolutions for the purchase of land or placement of land into trust status


NOW THEREFORE BE IT FINALLY RESOLVED, that this resolution shall be effective two weeks after adoption, that the General Manager shall be responsible for informing units of the Tribe regarding this resolution, and that the Tribal Secretary's Office shall be responsible for forwarding a copy of this resolution to all boards, committees and commissions of the Tribe.
