



Oneida proclaimed Purple Heart Reservation

To help remember Oneida Nation veterans who were wounded or killed in action the Oneida Business Committee (OBC) took official action and proclaimed the Oneida Nation a Purple Heart Reservation during the April 24 OBC meeting. This resolution recognizes the service and sacrifices made by combat wounded Oneida Nation veterans and makes Oneida one of only a handful of Tribal Nations across Turtle Island to hold this designation. The Oneida Nation Reservation signs will soon reflect this designation around the boundaries of the undiminished Oneida Reservation established in 1838.

The request for this resolution was brought forward by Military Order of the Purple Heart (MOPH) Wisconsin Commander George Greendeer and MOPH Chapter 164 Vice Commander Cletus Ninham, both combat wounded Purple Heart recipient Oneida Nation Warriors.

“The reason we took on this project is because we’re hoping that seven or eight generation from now there will only be a memory of combat Purple Heart veterans killed or wounded in conflict,” Greendeer said. “The memory will be a Purple Heart monument to honor our warriors that fought during the various wars.”

The Purple Heart is a United States military medal awarded in the name of the President of the United States to those wounded or killed while serving their country in wartime. Numerous Oneida Nation Warriors have distinguished themselves in combat across the ages fighting to protect two governments under two flags: the Oneida Na-

tion and the United States of America.

Although a work in progress, here are the names of some brave Oneida Warriors who are known at this time to have received the Purple Heart: Cletus Ninham (U.S. Army, Vietnam), George Greendeer (U.S. Army, Vietnam), Roger ‘Reggie’ Metoxen (U.S. Army, Vietnam), Junior Parker (U.S. Army, Korea), Leon House (U.S. Marine Corps, Vietnam), Eastman Skenandore (U.S. Army, WWII), Ernest Skenandore (U.S. Army, WWII), Dave Cannon (U.S. Army, WWII), Edmund Powless (U.S.

Army, WWII), Frank Summers (U.S. Army, Korea), Roy House (U.S. Army, WWII), Valdor John (U.S. Army, Korea, Vietnam), Joseph Metoxen (U.S. Army, WWII), Marty Antone (U.S. Marine Corps, U.S. Army, Operation Iraqi Freedom) and Jerry Metoxen (Branch unknown, Vietnam).

Wayne “Buggin” Malone’s latest release Humanity Volume 1 has been nominated for the 2019 Indigenous Music Awards in the Best Rap/Hip Hop category.

“It’s been six months since I put out this album ... and I already have three award nominations,” said Malone. “If I win that award, I’m going to dedicate it to our kids and to our future, and to our missing, murdered indigenous people.”

Malone self-released the album addressing political hot points such as the Dakota Pipeline protests after a seven-year hiatus from recording.

“I’m just surprised at how good it’s doing,” said Malone, stating he thinks

people are attracted to “the rawness and realness of my music.”

The Indigenous Music Awards recognizes First Nations music and musicians from Canada and the United States. The awards are voted on by music industry music professionals. The awards show will take place Friday, May 17 and can be viewed on powwows.com.

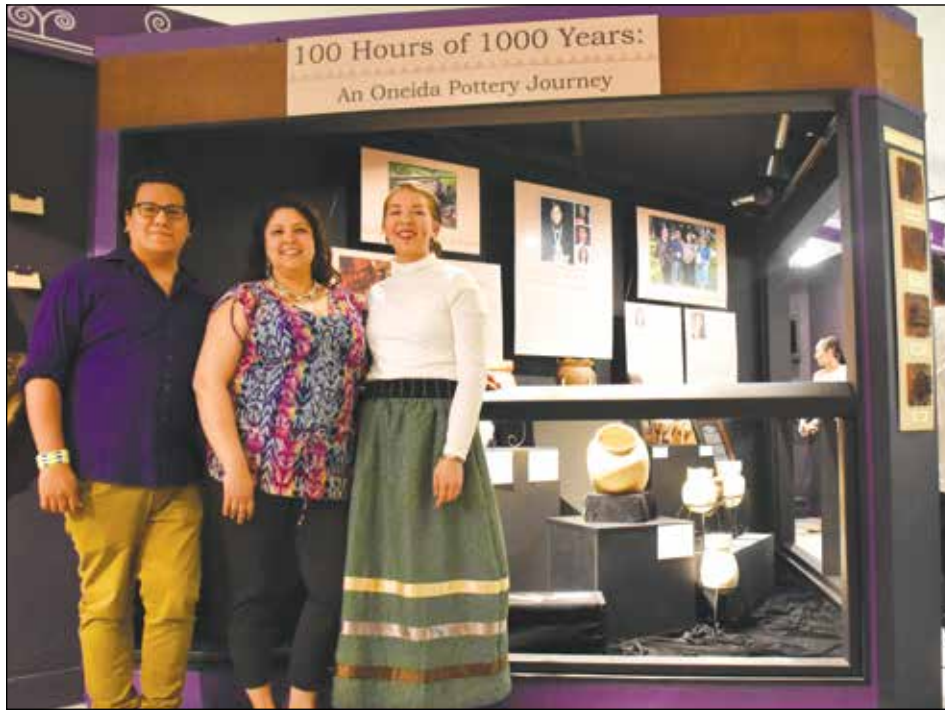

A new pottery exhibit titled '100 Hours of 1000 Years: An Oneida Pottery Journey' made its debut at the Oneida Museum April 24. Featuring the works of Oneida artists Eric Doxtator, Stephenie Muscavitch VanEvery, and Alana Dallas, the exhibit displays traditional and contemporary pottery. The artistic pottery was inspired by examples of historical pottery found in the Haudenosaunee homelands of present-day New York State which date back to the 12th century. Doxtator, Muscavitch VanEvery, and Dallas are mentees of reknowned Oneida Nation artist Jennifer Stevens. Stevens procured funding for the project from the Crazy Horse Foundation. The project will be on display at the Oneida Museum through May 2020. Packers bowling event will fund a unique initiative

(Green Bay, WI) ~ When it comes time to move, many children in the Foster Care or child welfare system carry their personal belongings in a garbage bag, because they don't have a suitcase or duffel bag. In Wisconsin, that is about to change.

As part of the 2nd annual "I Am For the Child Day," the Green Bay Packers and the Wisconsin CASA Association announced that proceeds from the June 5, 2019 Packers Give Back Celebrity Bowling Event will be used to launch "My Stuff, My Bag." This program's goal is to provide Foster children in Wisconsin their own suitcase to carry their personal belongings. To kick off the program, the Green Bay Packers donated the first suitcases.

"Being in the child welfare system is difficult for children," said Wisconsin CASA State Director Sue Schwartz. "If we can provide them with a new suitcase or duffel bag for their personal items,

think of the sense of pride and ownership it will give these youngsters. No longer will they need to use a garbage bag. It signifies that their stuff, their belongings, matter." The suitcases will be filled with personal care items such as pajamas, a pillow, blanket, books and toiletries before being given to a child.

Anna Linsley, a Wisconsin CASA spokesperson along with her husband, Packers Center Corey Linsley, added, "This is something so simple, so dignified, and it has the potential to make such a big difference in the life of a child who is already going through a hard time. It is something that is theirs and theirs alone, and gives them a place to store as well as transport their clothes and other items."

Amanda Wery, Community Outreach Senior Coordinator for the Green Bay Packers, added, "We are excited to support WI CASA through the Packers Give Back Celebrity Bowling Event.

We strive to positively impact our youth. This program, coupled with the important work CASA does, will make a difference."

In 2018, Wisconsin CASA provided a specially trained volunteer Advocate to 975 children, a 27 percent increase from 2017. However, there were nearly 7,000 additional children in need who could not be paired with an Advocate because of a shortage of county programs and volunteers. Wisconsin CASA currently provides support to programs serving 11 Wisconsin counties.

"We want to thank the Green Bay

Packers and Packers Give Back for partnering with us on this effort as well as the celebrity bowling event," added Schwartz. "We know it may take us a few years to get a suitcase to every Foster child in the state, but it's a goal well worth pursuing."

Summer Youth Employment Youth Ages 14 – 24

The Oneida WIOA Job Training Program is taking applications for the 2019 Summer Youth Work Experience Program. The Program is for youth ages 14 - 24, and provides an opportunity to explore careers, develop employment skills and gain work experience. - Verification that the youth has a medically-diagnosed disability (cognitive, emotional or physical which includes ADD, ADHD, LD, and ED). A school IEP can be used for verification. Youth is considered a family of one for income purposes, or
- Proof that the total household income for the last 90 days does not exceed the Federal Poverty Line Gross Monthly Income, or 70% of the Lower Living Standard Monthly Income or
- Receives or in the past six months has received TANF, Food Share, State or local income-based public assistance

or

- In-school youth who is homeless or
- Proof that the in-school youth is living out of home through a court-ordered placement. Youth is considered a family of one for income purposes or
- Receives or is eligible to receive free or reduced meals at school or
- Youth who is pregnant or is a parenting teen or
- Youth between the ages of 16 – 24 who has dropped out of school or hasn't attended high school for the last quarter.

Greeting everyone. It has been a very busy April. Time seems to be flying by. I have a few legislative updates to share with you in this issue.

Purple Heart Reservation

George Greendeer, Oneida Member, Vietnam Veteran, Purple Heart recipient and State Commander of the Military Order of Purple Heart (MOPH) along with local Purple Heart recipient, and local MOPH Chapter 164, Jr. Vice Commander, Cletus Ninham contacted my office with a request to proclaim the Oneida Nation in Wisconsin a Purple Heart Reservation; to recognize all Oneida Nation warriors who have been killed in action or wounded in combat while serving in the military protecting one land, two nations. Our military members serve and protect the United State of America, and the Oneida Nation. The Business Committee passed this resolution on April 24, 2019, supporting all our military members who are active or prior service. Oneida joins the Sisseton-Wahpeton Sioux Tribe, and Fort Hall; two other Tribal Nations who also made this same proclamation. It is a great honor to introduce this legislation to recognize all our purple heart

Our youth are our future leaders. Oneida has approximately 1,450 students attending public schools. It is important that they are aware of our history, from pre-European contact to present day. This year I am working on a pilot program with the Oneida Nation High School to take the graduating senior class on a "Homelands Tour & Youth Exchange" which include a trip to our homelands in New York. My goal is to expand this project to all graduating Oneida seniors. Our history is very important, and our ancestors made many sacrifices to our nation. This history needs to be shared with our youth, so they can carry on their stories in their hearts and minds when it is their time to lead our great nation.

Legislative Updates

Collectively the Oneida Business continues to work with all the other Wisconsin Tribes on State and Federal Laws that impacts all our Nations. We recently hired a General Manager to handle day to day operations, which will provide the Business Committee with more time to focus and concentrate on government to government relationships and legislation that impacts our nation, our sovereignty, our land, and way of life. Working to protect our rights requires me and all other BC members to be active on other committees and board outside of our Nation; we all attend and serve on other committees with other Tribal Nations, local, state, and federal governments. Here are a few notable projects

- standards for American Indian studies.
- Assembly Bill 106: Informational materials related to a school board's obligations to provide instruction on American Indians.
- Assembly Bill 107: The American Indian studies requirement for teacher licensure.
- Assembly Bill 108: Requiring private schools participating in a parental choice program and independent charter schools to provide instruction in American Indian history, culture, and tribal sovereignty.
- Assembly Bill 109: Required instruction in American Indian studies in the elementary and high school grades.

Attending Hearings and Providing Testimony

On May 2, 2019 I am traveling to Madison to provide testimony for State Assembly Bill 104 "Battery or threat to an officer of the court in a tribal proceeding and providing a penalty." This bill is being introduced by the State/Tribal Relations Committee, a committee that I serve on. We are seeking, to amend Wis. Stat. §940.203 so that a person who intentionally causes or threatens to cause bodily harm to the person or a family member of an "advocate" (an individual who is representing the interests of a child, the tribe, or another party in a tribal court proceeding) is guilty of a Class H felony. This bill enhances criminal penalties that seeks further protections for the Oneida Judiciary's guardians ad litem and lay advocates that are admitted to practice in our Nation's Judiciary. Our Judiciary has over 220 cases annually and 2,300 plus total visitors.

Lobbying Our Local State Legislators
In April I attended a town hall meeting, on the state budget that was held in the Town Freedom that was hosted by

our area State Representative and Majority Leader, Jim Steineke. I advocated for budgeted items for all Wisconsin Tribes. Representative Steineke held several town halls meetings just outside of the Oneida Township area. I encourage all Oneida Community members to attend these open meetings and support our Nations effort to protect our sovereign rights for self-governance, clean air, and water.

Executive Order #39

I am also working with all the other Wisconsin Tribes on the State Tribal Caucus committee on the state tribal consultation policies. Wisconsin Executive Order #39 was signed into law February 27, 2004 by Governor Jim Doyle. This law is a comprehensive initiative aimed at increasing ties between the state agencies and tribal Nations to improve state-tribal partnerships to ultimately improve services to tribal and non-tribal members living within tribal territories located in the state of Wisconsin.

These are but a few legislative updates that I have been working on for our Nation. I will provide more updates in my next editorial. If you have any suggestions on how we can improve anything within our Nation, please contact me or any of the Business Committee members.

I'm fortunate to have some community members gift our home with some of their maple syrup. It is also great to see the lacrosse season has started and all the kids out there practicing rain or shine, it shows their hard work and dedication for the Creator's game.

The United States Army (Army) is working with the families and tribes of the decedents to honor the families' wishes. Some families are seeking to return their ancestors' remains to tribal lands, while other families are choosing to keep the remains at CBPC or to modify headstones.

After extensive research done by the Oneida Cultural Heritage and the Oneida Enrollments Department they identified 109 community members as a descendant of an Oneida tribal member that passed away while attending the Carlisle Boarding School in Pennsylvania over one hundred years ago.

Back in October 2018 we held a special meeting with community members descendants and the Army Corp of Engineer's to discuss options that will be available to descendants of the tribal members listed above; these include the following: Repair the headstone; Care for the grave site forever; and/or ACOE will exhume, examine, casket, transport, and re-inter the remains at a cemetery of the family's choice.

To date we have three families that will be moving forward this summer with the disinterment associated with Jamima Metoxen, Ophelia Powless, and Sophia Caulon. The archaeological and anthropological team from the US

Army Corps of Engineers (USACE) will excavate the graves one at a time and then analyze the remains. From June 15th to June 21st, they will complete this process for the three decedents. They will be holding a transfer ceremony to signify the Army officially transferring the care of the decedents back to the families. Family members still have the option to move forward for the remaining five members buried at Carlisle and are encouraged to turn in forms as soon as possible due to the project requiring

extensive planning, contracting, and budgeting well in advance to schedule the disinterment for 2020.

In closing, I want you to know I will be attending this disinterment in Carlisle, Pennsylvania on behalf of my family. As we closer to the final stage of this returning of the remains there will be a service of some sort in our community.

Carlisle Update

The Carlisle Indian Industrial School was established and operated by the Bureau of Indian Affairs between 1879 and 1918. Many young Native American students died of illness or disease while attending the school. At least 180 Native American students are buried in the Carlisle Barracks Post Cemetery (CBPC) and the CBPC Native American Decedent List indicates that six of these children were Oneida. The following are the Oneida tribal members that are buried at the Carlisle Boarding School cemetery: Sophia Coulon, Melissa Metoxen, Jemima Metoxen, Jemima John, Frank Green, Ophelia Powlas, and Paul Wheelock.

Yukwatsistay[^]: A sober gathering place

Humble and soft-spoken, Makenit Cornelius, can be described with the phrase, “still waters run deep.” She is a student at the Fox Valley Technical College in the marketing program, and like many young women in our community is she a single parent. One would never guess what tragedy has befallen her, her mother, and her children.

Makenit knows the emotional trauma that come from the death of loved ones who commit suicide or who die from drug overdoses. Both her own father and late husband Daniel Gutierrez died in such circumstances. But, suicide and drug addiction will not be the legacy for her children and grandchildren. She is working hard to break those chains for her children and for others in the community.

“If I was too shy to admit that Daniel was using drugs again, how could I help him or how could anybody else help,” she ponders.

Makenit wants to help her children and others understand more about the issues of suicide and drug addiction and what kind of problems and complications that arise from that. “If they have more awareness about it and how to find help or resources to overcome it, then we can break the cycles of suicide and drug addiction,” she said.

As part of her college requirements, she is engaged in an internship to practice her skills in marketing and learn more in the field. She chose to do an internship at the Yukwatsistay[^], an Oneida tribal community gathering place in Green Bay, Wisconsin. Yukwatsistay[^], (pronounced like yung-wa-GEE-sty). It’s an Oneida language phrase that translates to “Our Fire, Our Spirit Within Each of Us.”

This community driven program was initiated after co-founders Debra Valentino and others formed the “Enough is Enough” movement in Oneida, WI, in 2017. They came together after the drug overdose death of Daniel Gutierrez.

His death struck Valentino hard and she often describes him as a fun-loving and sincere guy who was learning his Oneida language and culture with a group in the Oneida Cultural Heritage department.

Yukwatsistay[^] is a nonprofit grassroots organization made up of community members who have a solid passion to help build a Stronger Community. It’s a sober gathering place for individuals to go to and talk to someone if needed, or sit in silence, take part in one of their circles or potluck dinners, events, fundraisers, or meet and mingle with other sober individuals, according to their Facebook group page.

“What we’re dealing with (in the community) is that people are afraid to be judged or they’re silent about (suicide and drug addiction),” Makenit said. The board members and Recovery Coaches at Yukwatsistay[^] know about the issues and problems with alcohol and drug addiction. They are there to listen and help people whether it’s in talking circles, or one to one counseling, or fellowship.

Makenit recently became a Certified Recovery Coach along with several other members of the Yukwatsistay[^] Sober Gathering Place. They received their training through the DarJune Foundation, Inc., a licensed non-profit located in Green Bay, Wisconsin.

A certified Recovery Coach is trained to focus on providing individuals with the skills needed to guide, mentor, and support anyone would like to enter a or sustain long-term recovery from addiction from alcohol or other drugs,

“Anyone can come (to Yukwatsistay[^]) and take part in any of our activities, meetings, speakers, groups or talking circles, breakfasts, or fundraisers,” Makenit said. They have a fun fundraising activities there, too, like Cribbage Tournaments, haircut specials, and raffles.

One-Act Comedy and Discussion Set for May 8 at CMN in Green Bay

The staged reading of an original student play debuts at the College of Menominee Nation's Green Bay campus on Wednesday, May 8. The script is the work of CMN student playwrights Chantelle Kuchta, Marisa Munoz, Jeremiah TwoCrow and Curtis Wilhelmi.

A one-act comedy, "The Half-Red Wedding" is billed as a show about commitment, broken promises, and wild rice casserole as experienced in the local setting of Oneida's Parish Hall. The presentation begins at 3:30 p.m. at

CMN's Green Bay/Oneida campus and is followed by a discussion of the work. Parking and public entry is located at the north cul de sac on Allied Street, north of the Oneida Street and Waube Lane juncture.

CMN's American Indian theater studies program and the annual spring semester playwriting class are led by Professor Ryan Winn.

Winn says he starts the course by asking students to focus on a story that needs to be told, experienced, learned

from, and remembered by local audiences. He then asks them to reflect on Lloyd Kiva New's "Credo for American Indian Theatre," which calls theater a perpetual "mirror of the age for each generation," and proposes that "Indian people today desperately need such a mirror."

Subsequent coursework includes lectures on the mechanics of playwriting and discussion of plays by prominent Native and non-Native writers.

"We use the discussions as a launching pad for ideas concerning the setting and theme of the script we will write," Winn says, "and then each student drafts a first person narrative about the specifics of his/her fictitious individual character."

Narratives describing each character's upbringing, education, employ-

ment, home life, ambitions, quirks, and hidden secrets are shared in the group and commented on before the characters are placed in a setting and given relationship to the others within the play's world. With this script framework in hand, students write scenes which are edited together to advance the plot. For presentations like "The Half-Red Wedding," class members take roles and read the new script aloud, editing and revising as they go.

Winn says the reading and discussion are free and open to the public; refreshments follow the reading. Visitors to the campus are asked to enter from the Allied Street cul de sac parking lot.

The College of Menominee Nation is an accredited baccalaureate institution with enrollment open to all at campuses in Keshena and the Green Bay location.

Darryl LaCounte Named Director of the Bureau of Indian Affairs

WASHINGTON – Assistant Secretary ~ Indian Affairs Tara Mac Lean Sweeney today announced that she has appointed Darryl LaCounte to the position of director of the Bureau of Indian Affairs (BIA) in the U.S. Department of the Interior. LaCounte, a member of the Turtle Mountain Band of Chippewa Indians in North Dakota, has served as acting director since 2018. His appointment is effective April 28, 2019.

Assistant Secretary Sweeney is committed to providing consistent and focused leadership for the BIA, as well as to actively collaborate with the Department's senior managers. Among her top priorities is to fill all of the bureau's leadership positions with highly qualified managers who will provide continuity and expertise in trust management in accordance with its mission.

"Ensuring that key leadership positions are filled is important for Indian Affairs' success and the Department's relationship with Indian Country," Sweeney said. "Mr. LaCounte has done

a superior job over this past year as the acting director of the Bureau of Indian Affairs. He is clearly committed to the trust responsibility and the further development of our vital workforce, which is the foundation for our ability to deliver services to the tribes."

"When I was asked to step in to be the BIA's acting director, I felt a strong responsibility to the people behind the work – the Indian Affairs employees, the tribes, and the Indian and Alaska Native people we serve," LaCounte said. "In accepting this appointment as BIA director, I want to thank Assistant Secretary Sweeney for her confidence and support. Because I believe in our mission, I am committed to improving the way we accomplish it and to upholding the federal trust responsibility now and for future generations."

LaCounte began his federal career in 1988 at the Bureau's Wind River Agency in Fort Washakie, Wyo., as an oil and gas specialist in the real estate services branch of the Office of Trust Services.

Since 2015, he had been regional director of the Bureau's Rocky Mountain Regional Office in Billings, Mont., which serves eight federally recognized tribes in Montana and Wyoming. He went on to serve as the acting deputy bureau director for Trust Services at the

BIA's headquarters in Washington, D.C., beginning in February 2018. He was named the acting BIA director in April 2018.

LaCounte received a Bachelor of Arts degree from Eastern Montana College (now Montana State University) in 1986.

The Assistant Secretary – Indian Affairs oversees the BIA, the oldest bu-

reau in the Department of the Interior. The BIA director is responsible for managing the bureau's day-to-day operations through four offices – Indian Services, Justice Services, Trust Services, and Field Operations. These offices directly administer or fund tribally operated BIA infrastructure, economic development, law enforcement and justice, social services (including child welfare), tribal governance, and trust land and natural and energy resources management programs for the nation's 573 federally recognized American Indian and Alaska Native tribes through 12 regional offices and 81 agencies.

Reward now offered for public's help in wildlife and dog fatal poisonings in northern Wisc.

Reward now offered for public's help in wildlife and dog fatal poisonings in northern Wisconsin counties

The U.S. Fish & Wildlife Service, Wisconsin Department of Natural Resources and the U.S. Forest Service are seeking the public's help in solving several cases involving the poisoning deaths of wildlife and domestic dogs since December.

The Service is now offering a reward of up to \$1,000 for information that leads to the arrest and/or charges being filed against a responsible party.

Dog deaths have occurred in Bayfield, Marinette and Florence County; however, it is unknown if other counties could be involved. In addition to the unfortunate poisoning of these family pets, investigators also found dead coyotes, weasels, raccoons and one wolf that they suspect also were poisoned. Lab

tests are underway to confirm the cause of death in these wildlife cases.

The deaths occurred on public properties in these counties managed by the U.S. Forest Service and the Goodman Timber Company.

Investigators say the poison was found on the ground in rural areas and subsequently was ingested by the dogs. Each dog died in less than 30 minutes after ingestion. People walking their pets are recommended to keep them on leashes to restrict their movements off of roadways to avoid possible contact with any poison.

The U. S. Fish and Wildlife Service asks anyone with information about the recent wildlife and dog deaths to contact the Service Office of Law Enforcement in Madison, Wisconsin at 608-221-1206.

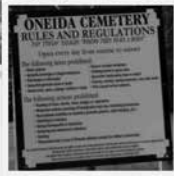

Plots are available to Oneida Nation members, his or her family, and descendants.

A plot fee of \$ 100.00 will be charged and must be paid at the time of purchase. The remainder of fees will need to be paid prior to the burial.

If you're ordering a plot at the time of the burial, a fee of \$ 150.00 must be paid at the time of purchase. This amount includes: plot fee & plot marking fee. An additional fee for marking the monument (headstone) will be \$50.00 which needs to be paid prior to the placement of the base.

Here is a listing of fees:

- \$ 100.00 / plot
- \$ 50.00 / plot marking
- \$ 50.00 / marking monument (headstone)
- \$ 125.00 / additional winter burial charge

Please note: Land Management only takes checks or money orders.

When purchasing a plot you must have the following verification at the time of purchase:

1. Enrollment verification
2. Social security number
3. Date of birth
4. If the plot is for a spouse of an enrolled member a marriage certificate must be presented.

Greenpeace drops effort to move lawsuit venue

BISMARCK, N.D. (AP) ~ Greenpeace is dropping an effort to move a lawsuit alleging it conspired against the Dakota Access oil pipeline from North Dakota state court to federal court — a possibly friendlier venue to the environmental group.

Greenpeace had cited federal law dealing with court jurisdiction to try to get the state case moved to federal court, where the group had already prevailed against racketeering claims alleged by Texas-based pipeline developer Energy Transfer Partners.

ETP disputed Greenpeace's argument that federal court had jurisdiction over its latest lawsuit. Greenpeace attorneys in a late Friday court filing acknowledged the company was correct and agreed to leave the lawsuit in state court.

"Plaintiff's relentless vendetta risks chilling the advocacy of Greenpeace and other environmental groups, and if adopted more broadly by big industry as a strategy, has more ominous implications for advocates across the political spectrum who face large corporations with deep pockets," attorney Derrick Braaten wrote in a recent filing.

ETP alleges Greenpeace and activists conspired to use illegal and violent means such as arson, harassment and misleading information to disrupt pipeline construction and damage the company's reputation and finances.

Groups and Native American tribes

that feared environmental harm from the pipeline staged large protests that resulted in 761 arrests in southern North Dakota over a six-month span beginning in late 2016. The pipeline that ETP maintains is safe began moving North Dakota oil through South Dakota and Iowa to a shipping point in Illinois in June 2017.

ETP sued Greenpeace and others in federal court two months later, making claims under the federal Racketeer Influenced and Corrupt Organizations Act and under North Dakota laws. U.S. District Judge Billy Roy Wilson eventually ordered the company to amend what he criticized as a "vague" lawsuit and ultimately dismissed the case in February.

Wilson did not rule on the state claims, however, and ETP sued in state court a week later. Greenpeace made a technical argument for moving the dispute back to federal court. The group cited a federal law stipulating federal courts have jurisdiction over cases in which the plaintiffs and defendants are in different states. ETP attorney Lawrence Bender effectively argued that was not the case.

Braaten in court filings alleges ETP's current "convoluted suit" is really aimed at saddling Greenpeace with "extraordinary litigation costs" and silencing the group's public criticism.

recent memorandum. Summers wrote that Ninham was drafted into the United States Army during the Vietnam War. Following Basic Training, Advanced Infantry Training, and Airborne Jump School, Ninham was sent to Vietnam and assigned to the 173rd Airborne Division and later reassigned to the 101st Airborne.

On Ninham's first combat mission, his platoon came under heavy enemy fire which killed or injured many of his brothers-in-arms. Ninham and his platoon sergeant attempted to retrieve their wounded lieutenant, but in the ensuing rescue attempt the sergeant was also hit requiring Ninham to now try to save both men. Under heavy enemy fire, Ninham heroically managed to bring both men back to cover. Ninham was later awarded the Bronze Star with a "V" for valor for his actions during this mission.

Later during the same deployment, Ninham's team was sent on a search-and-destroy mission in the Vietnamese highlands with orders to take down a Viet Cong stronghold. During the mission one of his platoon mates stepped on a booby-trap which exploded and severely injured several soldiers including Ninham. Near death and with shrapnel wounds riddled throughout his lower body, Ninham was forced to endure more than a day of unimaginable

pain without morphine as he waited to be airlifted out of the area. He survived his ordeal but had to undergo several surgeries while recovering from his life-threatening wounds. While in recovery Ninham was awarded the Pur-

ple Heart and approximately one month later was right back in action with the 327th Infantry Regiment of the 101st Airborne Division.

Ninham finished his tour of duty in Vietnam a few months later and eventually returned home to Oneida. He now serves as Commander of the Oneida Veterans of Foreign Wars (VFW) Robert Cornelius Post 7784.

"This (Purple Heart Reservation designation) is a great accomplishment to be able to honor all the wounded men and women who've served in all the wars from the Revolutionary to the present," Ninham said. "A lot of people don't realize that, being a sovereign nation, Oneidas fought under two flags to protect two nations that are one home. It's times like this that make me proud to be an Oneida and a veteran. I just want to say, 'Thank you,' to all the people that were involved in making this come about."

The Oneida Nation is currently in the

process of compiling a more comprehensive list of combat wounded Oneida Warriors who have received the Purple Heart. If there are any recipients, relatives, or friends of recipients who are aware of any Oneida citizen who received the Purple Heart but is not listed in this article, please contact VFW 8th District Commander and Executive Assistant to the Secretary Chris Cornelius at (920) 869-4434.

The Oneida Nation will also be breaking ground on a Purple Heart Memorial dedicated to recipients of the United States' oldest military medal. The ceremony is scheduled to take place May 18 at the Oneida Veterans Memorial Wall grounds on Highway 54 at 1:30 p.m. The project is expected to be completed by Memorial Day 2020.

"I'm really excited about this project because of what it's going to do for Oneida," Greendeer said. "It's going to help wake up our Memorial park over on Hwy. 54. In addition to the wall and eagle we'll now have a plaque representing the different branches of service. In time as that becomes more popular it will lead to more benefits near the park like washrooms and other things that are needed. One good thing always leads to another."

Deb Ushakow Retires After A Quarter Century of Service

It was 18 years ago on April 15, 2001 that Deb Ushakow began her employment at Southeastern Oneida Tribal Services (SEOTS). Prior, she was employed as an X-Ray Technician at St. Luke's Medical Center for 16 years. During the last eight years of her employment at St. Luke's she donated significant time volunteering at SEOTS before becoming a permanent employee. She volunteered so much that twice she was recognized as 'Volunteer of the Year.' Combined, Deb has poured herself into serving the SEOTS community for the past 26 years.

Thinking back upon her eight years of volunteering, she was strongly driven by her passion for the history and culture of the Oneida Nation. "It seemed like I could never get my fill of anything to do with the culture. So, I helped Mindemoye organize and teach cultural classes such as beading, history, outfits,

conferences, set up the reading program, candidate forum, facilitated the booth at Indian Summer and well I don't want to bore you, but I loved every minute of it!" recalled Deb.

When a position became available at SEOTS, she applied. Unfortunately, her first application was denied. Never being one to accept 'no' as an answer, Deb waited six months and applied again. The second time was the charm and Deb was hired as the Community Services Specialist.

Her many years of service to the community has left her with countless fond memories. Most of those memories centered on the people and families that she worked with.

Working with Mark Denning helped her to grow in many ways. "He encouraged me to do a lot for the community." With a mission related to cultural education and wellness, she had a full plate of programming to offer to the community. "Our programming could be anything that was related to the arts, language, community meetings, education, and the welfare of our Oneida community."

Throughout her service, there were always two constants – culture and community. Whether it was working with families, volunteers, Elders (in 2008 she started the weekly Elder Activities that have flourished at SEOTS), or community members, Deb has always shown a deep commitment to help people to live a happier life. "Seeing people happy makes me happy."

Often, her service to the community was achieved through cultural education. "The thing I like best about SEOTS is families getting to know their culture, each other, and what our grandmothers and grandfathers were about." But, cultural education was not the only hat she wore.

Deb was not one to shy away from

other challenges in the community. Through her direct support Deb has assisted individuals and community members to address substance abuse, domestic abuse, homelessness, and many other issues. "Everybody needs to be valued. Everybody needs to be hugged." She also created programming to educate the community on these social ills.

In addition to her role at SEOTS she served the community as one of the founders of the Wisconsin Pink Shawl Initiative, which has focused on building awareness around breast cancer and early detection. She has also presented her Traveling Museum to more than 300 people.

Walking away from a career that she loves was not an easy decision. However, she has a plan in place. She hopes to continue to volunteer in the community, become more active with her church, learn guitar, be active with golf, darts, and bowling, and dedicate more time to family.

What is obvious is that Deb has created a legacy of care and compassion for the people in her community. So many lives touched and so many lives improved. She made a difference not because of her job or title, but because of her character. And while 26 years (8 as a volunteer, 18 as an employee) of service with the Oneida Nation is an amazing accomplishment, it is but a single chapter in a life dedicated to God, family, and community. On April 30, 2019 SEOTS celebrated her incredible career.

Judge denies Republican's attempt to join abortion lawsuit

MADISON, Wis. (AP) ~ A federal judge on Tuesday rejected Wisconsin Republican lawmakers' attempt to intervene in a Planned Parenthood lawsuit challenging the state's abortion restrictions, saying in a strongly worded order that they presented no evidence that the Democratic attorney general wouldn't adequately defend the laws.

U.S. District Judge William Conley wrote in his ruling that the lawmakers failed to demonstrate a right to intervene and that allowing them to join "would likely infuse additional politics into an already politically-divisive area of the law and needlessly complicate this case."

Planned Parenthood sued in January seeking to repeal requirements that only doctors perform abortions, that women seeking abortion-inducing drugs see the same doctor twice and that doctors be present when dispensing the drugs.

Democratic Attorney General Josh Kaul is defending the restrictions, but Republicans hired their own attorneys at taxpayer expense because they don't trust him, saying Kaul supports abortion rights and Planned Parenthood's agenda.

Kaul was endorsed by Planned Parenthood in last year's election and received more than \$80,000 from its political action committee. Earlier this year, Kaul joined a multistate lawsuit originating in California challenging the Trump administration's attempts to set up obstacles for women seeking abortions.

But the judge said the attorney general has a duty to defend the laws of the state and that the Republican lawmakers didn't offer any evidence that Kaul intends to not fulfill that responsibility. Conley said the evidence that Republicans did present "fails to demonstrate (or even come close to demonstrating) either gross negligence or bad faith."

He also noted that the same Department of Justice attorneys who "previously diligently defended abortion

regulations in this court" and on appeal have been assigned to the latest lawsuit.

"There is nothing to suggest that they will not fulfill their ethical obligations," Conley said.

Kaul and Planned Parenthood both opposed the lawmakers' attempts to intervene.

The judge said the Legislature didn't show why it needed to intervene, noting that its interest in defending the constitutionality of the laws "is the same as that of the defendants." He also rejected their argument that an adverse ruling could impact the Legislature's ability to pass abortion-related legislation in the future.

Kaul's spokeswoman Gillian Drummond declined to comment.

Senate Majority Leader Scott Fitzgerald, a Republican who sought the intervention along with Assembly Speaker Robin Vos, said they were reviewing the ruling and deciding what to do next. They could appeal to the 7th Circuit Court of Appeals.

"Pro-abortion groups waited years to challenge these laws until they had an ally in the Attorney General's office," Fitzgerald said in a statement. "We have concerns about Josh Kaul's willingness to aggressively defend pro-life laws that are already on the books."

Lester Pines, an attorney for Planned Parenthood, said it doesn't base its legal strategies on who is serving as attorney general.

"If there are laws that unconstitutionally restrict women's access to reproductive health care, including abortion, they deserve to be challenged no matter who represents the State (sic) in court," he said.

The lawsuit targets state laws signed by former Republican Gov. Scott Walker that make it more difficult for women, particularly in rural areas, to obtain an abortion.

Planned Parenthood wants to repeal laws requiring that only doctors perform abortions, that women seeking medicine that causes abortions see the same doctor on two separate visits, and

that doctors be physically present when dispensing abortion-causing drugs.

The lawsuit asserts that the laws violate women's constitutional right to privacy under the 14th Amendment's

guarantee of due process and the rights to equal protection under the law for Planned Parenthood's doctors, nurses and patients.

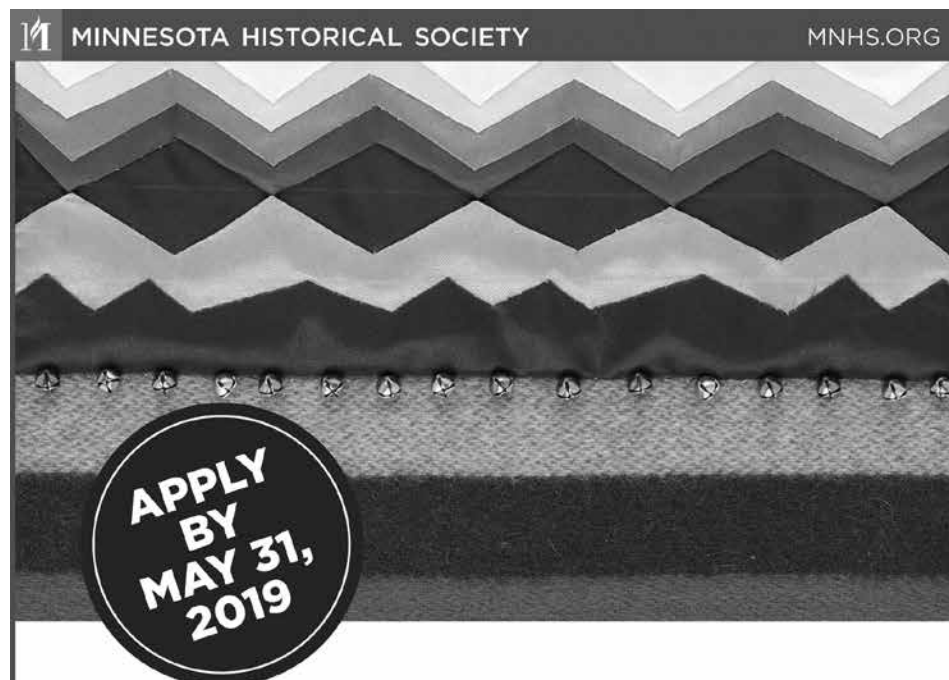

Oklahoma governor combines Columbus, Native American days

OKLAHOMA CITY (AP) – A bill that a broad coalition of Native American groups endorsed to celebrate a day for indigenous people on Columbus Day was signed into law Thursday by Oklahoma Gov. Kevin Stitt, the first governor in the U.S. to be enrolled as a member of a Native American tribe.

The Republican said the bill was a fair compromise that gives Oklahoma residents an opportunity to celebrate both

the 15th century explorer Christopher Columbus and the state's indigenous people.

The Inter-Tribal Council of the Five Civilized Tribes, which represents more than 750,000 tribal citizens, passed a resolution earlier this year urging Stitt to sign the measure.

“I think moving it to Columbus Day, I don't see any downside to it at all,” Stitt said. “It just gives us one opportunity to celebrate Columbus, but also the indigenous people here in America.”

Oklahoma is home to 39 tribes, and

more than 7% of the population identifies as Native American, one of the highest proportions in the nation.

Unlike similar measures approved in several other states, including New Mexico earlier this month, the bill does not replace Columbus Day. It moves Oklahoma's current Native American Day from November to the second Monday in October.

Several Oklahoma communities, including Oklahoma City and Tulsa, have already approved similar citywide resolutions.

Oklahoma's ex-Republican Gov. Mary Fallin vetoed a similar bill last year, saying in her veto message that combining the two holidays “could be viewed as an intentional attempt to diminish” support for Native American Heritage Month in November.

But Fallin's veto last year upset many Native Americans who felt she was insensitive to the issue, said Brandon Scott, a Cherokee Nation citizen and the editor of the tribe's newspaper, the Cherokee Phoenix. For many Native Americans, Scott said, Columbus is symbolic of the colonial movement that led to the

death and forced assimilation of indigenous populations.

“I think if you asked, you'd be hard-pressed to find anyone in a Native community who says: ‘Oh yeah, Columbus was a great guy, let's be sure to honor him,’” Scott said. “A lot of this has to do with providing an alternative to Columbus Day. In reality, he did horrible things to the indigenous populations where he landed.”

Stitt's signing of the bill was quickly praised by some of the state's most powerful tribal leaders.

The change “offers another opportunity to recognize Native Americans as an essential element in the fabric of Oklahoma history, heritage and society,” Chickasaw Nation Gov. Bill Anoatubby said in a statement.

Cherokee Nation Principal Chief Bill John Baker said the day will be an opportunity “for people across the state to celebrate and honor the significant contributions of Native tribes as well as the beautiful culture of our Native people.”

Wisconsin's migration patterns threaten workforce

MADISON, Wis. (AP) ~ Wisconsin has seen a steep decline in net migration of families with children and this could be problematic for efforts to replace the state's aging workforce, according to a new report.

The Wisconsin Counties Association's nonpartisan research arm, Forward Analytics, recently released a study that raises concerns about the state's migration patterns. The report claims that Wisconsin doesn't have enough young people to take over jobs from baby boomers set to retire in the coming 10 to 15 years, Wisconsin Public Radio reported.

“We've got to figure out how to turn that around and we've got to do it fairly quickly because baby boomers are nearing retirement,” said Dale Knapp, Forward Analytics' research director.

The state's migration of children dropped below 10,000 from 2010 to 2015. Before 2010, Wisconsin added 40,000 children from outside the state over a five-year period.

Wisconsin's birthrate has also declined to its lowest in four decades.

Former Gov. Scott Walker launched a marketing campaign last year to try to lure millennials, age 21 to 35, to the state. Wisconsin has struggled to retain younger millennials, who often prefer big cities and more entertainment options.

Knapp recommends that Wisconsin instead targets families that might want to settle in the state. He says Wisconsin can offer quality schools, safe neighborhoods and recreation.

Wisconsin court says gun site not liable in spa shooting

MADISON, Wis. (AP) ~ A firearms website that enabled a Wisconsin man to illegally purchase the pistol he used to shoot seven people at a suburban Milwaukee spa six years ago can't be sued over the incident, the state Supreme Court ruled Tuesday.

The court ruled 5-1 that federal law protects website operators from liability arising from their sites' design and functions. The ruling reverses a state appellate court finding that the federal Communications Decency Act grants website operators immunity only from lawsuits challenging site content provided by others and expands the act's breadth in Wisconsin.

Radcliffe Haughton's wife, Zina Daniel Haughton, had taken out a restraining order against him that prohibited him from possessing a firearm. But he bought a semiautomatic pistol and ammunition from a person he met through Armslist.com, according to court documents.

The site functions as an electronic classifieds page, with buyers and sellers posting want and for-sale ads for weapons and ammunition. According to court documents, Haughton used an Armslist.com function that allowed him to bypass ads from licensed dealers, enabling him to avoid a background check. Licensed firearms dealers must conduct such checks prior to purchase; private sellers aren't required to perform them.

He met the seller in October 2012 and bought the pistol and ammunition. The next day he opened fire at Azana Salon & Spa in Brookfield, where his wife worked. He killed her, two of her co-workers and wounded four others before he took his own life.

The Brady Center to Prevent Gun Violence sued in 2015 on behalf of Haughton's wife's daughter, Yasmeen Daniel, alleging the website's operator, Armslist LLC, was liable for the incident. Daniel

argued that the site's setup encourages illegal firearm sales because it allows buyers to avoid background checks and waiting periods, provides no guidance on laws governing firearm sales and allows users to remain anonymous.

Armslist attorneys countered that the Communications Decency Act renders website operators immune from liability stemming from their sites' design and functions.

The 4th District Court of Appeals last year rejected that argument and allowed the case to continue. The court said that the act ensures only that operators aren't liable for publishing content provided by someone else. That court refused to expand the act's immunity to site design and functions.

The Computer and Communications Industry Association filed amicus briefs with the state Supreme Court arguing that act provides immunity for website operators' "traditional editorial functions" and the appeals court's ruling resulted in the act meaning something different in Wisconsin than the rest of the country.

Several former members of Congress who supported the act also filed briefs with the high court, including former U.S. Reps. Jim Moran and Luis Guterrez. They argued the act doesn't protect website operators from their own actions. The National Coalition Against Domestic Violence as well as a host of other domestic violence groups also filed a brief urging the justices to adopt the appellate court findings.

"Armslist's promotion of illicit arms transactions involving known abusers must not be immunized under the CDA simply because Armslist does business on the Internet instead of in a dark alley behind the courthouse," the groups said.

Attorneys for Daniel didn't immediately return voice mail messages Tuesday morning.

Wisconsin Supreme Court says asking about gun allowed

MADISON, Wis. (AP) ~ A Milwaukee police officer did not violate the constitutional rights of a person pulled over for a routine traffic stop when the officer asked if they had a weapon in the car, the Wisconsin Supreme Court ruled Tuesday.

The unanimous Supreme Court overturned lower court rulings that said the police officer did not have reasonable suspicion to ask the question.

John Patrick Wright was pulled over late one night in June 2016 because of a broken tail light. The officer asked Wright he was a concealed weapons permit holder and if he had any weapons in the vehicle. Wright told police that he had recently taken a class to get a permit and that he had a gun in the car.

Police found a loaded gun in the glove compartment of the car. Wright had no permit to carry it and he was arrested on a misdemeanor for carrying a concealed weapon without a license.

The Milwaukee County Circuit Court ruled that Wright's traffic stop was legal, but it was unconstitutionally extended when the officer asked whether he had a

concealed weapons permit or had a gun in the car.

The state appeals court upheld that decision.

But the Supreme Court, in a ruling written by Justice Shirley Abrahamson, said none of the officer's actions or question violated the driver's constitutional protection against illegal search and seizure.

The state argued that officers may take negligible precautions during traffic stops, such as asking whether there are weapons in the car, to protect their safety. Courts have previously ruled that questioning during traffic stops can be extended if there are legitimate reasons to be suspicious.

The court agreed that in this instance, asking Wright about whether he had a weapon in the car was not unconstitutional because it didn't measurably extend the duration of the traffic stop.

"Questioning a lawfully stopped motorist about the presence of weapons related to officer safety and is negligibly burdensome," Abrahamson wrote for the court. "The question is part of the traffic stop's mission."
