- WHEREAS, the Oneida Tribe of Indians of Wisconsin is a federally recognized Indian Government and a Treaty Tribe recognized by the laws of the United States, and
- WHEREAS, the Oneida General Tribal Council is the duly recognized governing body of the Oneida Tribe of Indians of Wisconsin, and
- WHEREAS, the Oneida Business Committee has been delegated the authority of Article IV, Section 1 of the Oneida Tribal Constitution by the Oneida General Tribal Council, and
- WHEREAS, the Oneida Tribe has acquired in fee status the following parcel described as:
Former Edward C. Lemmen and Linda D. Lemmen Property
- WHEREAS, the parcel is described as follows:
Legal Description: See attached.
Tax Parcel Numbers: 6H-1155-5, 6H-1155-4
- WHEREAS, the above described parcel is requested in Trust Status to expand Oneida Tribal land base and provide an existing residential housing land use and will not be used for gaming purposes, and
- WHEREAS, the Oneida Business Committee certifies that the local property taxes will be paid up to trust placement,
- NOW THEREFORE, BE IT RESOLVED, that the Oneida Business Committee hereby requests that the United States Bureau of Indian Affairs initiate and carry out the process required to place the above parcels in trust for the Oneida Tribe of Indians of Wisconsin.

Parcel II:

That part of Lot Eleven (11), Section Thirty (30), Township Twenty-four (24) North, Range Twenty (20) East of the Fourth Principal Meridian, City of Green Bay, Brown County, Wisconsin, described as follows:
Beginning at the Northwest corner of Lot One (1) of the Certified Survey Map recorded in Volume 20 of Certified Survey Maps, Page 323, Brown County Records [being part of said Lot Eleven (11), Section Thirty (30)]; thence S 00° 36' 07" W, 82.69 feet along the West line of said Lot One (1) to the Northeast corner of Lot Two (2) of said Certified Survey Map recorded in Volume 20, Page 323; thence N 89° 54' 46" W, 163.00 feet along the North line of said Lot Two (2) to the Northwest corner of said Lot Two (2), also being a point on the East line of Crestwood Drive; thence N 00° 36' 07" E, 36.11 feet along said East line of Crestwood Drive; thence along the arc of a 12.00 foot radius curve to the right 18.74 feet, said curve having a chord which bears N 45° 20' 41" E, 16.89 feet to the South line of the West Mason Street Frontage Road; thence along said Frontage Road along the arc of a 325.00 foot radius curve to the left, 128.30 feet, said curve have a chord which bears N 78° 46' 40" E, 127.47 feet; thence continuing along said Frontage Road along the along the arc of a 325.00 foot radius curve to the right 28.15 feet, said curve having a chord which bears N 69° 57' 00" E, 28.14 feet to the point of beginning.
