### RESOLUTION # 4-03-02-C

Department of Health and Human Services/Administration for Children and Families Administration for Native Americans 2002-2004

- WHEREAS,** the Oneida Tribe of Indians of Wisconsin is a federally recognized Indian government and a treaty tribe recognized by the laws of the United States, and
- WHEREAS,** the Oneida General Tribal Council is the governing body of the Oneida Tribe of Indians of Wisconsin, and
- WHEREAS,** the Oneida Business Committee has been delegated the authority of Article IV, Section of the Oneida Tribal Constitution by the Oneida General Tribal Council, and
- WHEREAS,** the Oneida Tribe has developed and maintained the Cultural Heritage Department whose mission is to protect and maintain the Oneida traditions, language, customs, and history in a manner that shall promote the dignity and respect of the Oneida people and culture, and
- WHEREAS,** the Oneida Tribe realizes that our language is the basis of our history, culture, traditions, which gives us our identity, self-esteem and our sense of belonging as Indian people, and
- WHEREAS,** the Oneida Tribe has realized the urgent need to preserve our language and culture and is taking steps through an extended family and community effort and has and will continue to include the community in the planning, implementation and evaluation of this language preservation project.

**NOW, THEREFORE, BE IT RESOLVED:** That the Oneida Tribe of Indians of Wisconsin/Oneida Cultural Heritage Department authorizes and submits this grant application to the Department of Health and Human Services/Administration for Native Americans, to assist in the efforts of a community-wide Oneida Language and Culture family project.
