Oneidas bringing several hundred bags of corn to Washington's starving army at Valley Forge, after the colonists had consistently refused to aid them.

UGWA DEMOLUM YATEHE Because of the help of this Oneida Chief in cementing a friendship between the six nations and the colony of Pennsylvania, a new nation, the United States was made possible.

WHEREAS, the Oneida Nation of Wisconsin is a federally recognized Indian government and a treaty tribe recognized by the laws of the United States, and
 WHEREAS, the Oneida General Tribal Council is the governing body of the Oneida Nation of Wisconsin, and

WHEREAS, the Oneida Business Committee has been delegated the authority of Article IV, Section 1 of the Oneida Tribe Constitution by the Oneida General Council, and

WHEREAS, Congress by enactment of the Transportation Equity Act of the 21st Century (TEA21) provided a mechanism for Indian Tribes to exercise the right to SELF-DETERMINATION, and

WHEREAS, the Transportation Equity Act for the 21st Cen 1ry (TEA21), has provided funding to the Bureau Indian Affairs (BIA) for the purpose of Road onstruction on Indian Reservations, and

WHEREAS, the Oneida Nation granted a right-of-way to the Bureau of Indian Affairs for the Health Center Road located on the Oneida Nation Reservation and authorizes its Chairperson and Secretary to negotiate for the grading and surfacing of the same by virtue of Resolution 02-21-01-A, and

NOW THEREFORE BE IT RESOLVED: the Bureau of Indian Affairs, under Public Law93-638, has submitted to the Oneida Nation Contract No. CTF55T43345, for \$317,355.80 for the purpose of Health Center Road grading and bituminous surfacing.

NOW THEREFORE BE IT FURTHER RESOLVED: That the Oneida Nation hereby authorizes its Chairperson, Cristina Danforth, and Tribal Secretary, Julie Barton, to sign Contract CTF55T43345 for the above stated purpose.
