RESOLUTION # 4-30-03-A


Oneida Community Health Center/Dental Clinic/American Dental Association/Access to Care Grant Program

- WHEREAS,** the Oneida Tribe of Indians of Wisconsin is a federally recognized Indian government and a treaty tribe-recognized by the laws of the United States, and
- WHEREAS,** the Oneida General Tribal Council is the governing body of the Oneida Tribe of Indians of Wisconsin, and
- WHEREAS,** the Oneida Business Committee has been delegated the authority of Article IV, Section of the Oneida Tribal Constitution by the Oneida General Tribal Council, and
- WHEREAS,** the Oneida Tribe has determined its mission for the Oneida Community Health Center/Dental Clinic is to "provide a vital component of holistic health by working together as a team to guarantee quality dental care and improve the quality of life for the future of the Oneida Community", and
- WHEREAS,** the Oneida Tribe through the Oneida Dental Clinic would like to provide culturally sensitive, community based dental services for Oneida community elders, and
- WHEREAS,** the Oneida Tribe believes that the Oneida Family and Community will be strengthened by providing critically needed services that will have a positive impact on Elders with Diabetes and will assist in maintaining proper blood sugar levels and thereby, positively improving their quality of life and health status.

NOW, THEREFORE, BE IT RESOLVED: That the Oneida Tribe of Indians of Wisconsin/Oneida Community Health Center/Dental Clinic in collaboration with American Dental Association Foundation/Access to Care Grant Program, authorizes and submits this grant application for critically needed dentures for diabetic elders who live on the Oneida Reservation, who are currently active patients and who cannot financially afford dentures.
